Arthington Show – Sunday 19th July 2009

The Society is now accepting applications for outdoor Trade/Craft Stands at the 2009 show to be held on the large showground in Pool-in-Wharfedale, near Otley, Leeds.

Site fees will be chargeable at £12 per metre frontage, or depth (to the nearest ½ metre), whichever is the greater. The minimum size will be 2m x 2m. Trestle tables will be charged at £7 each and folding chairs £2 each. All Registered Charities may apply for Stands at 50% of this rate but will be charged in full for tables and chairs. A standard 10ft x 10ft gazebo is charged at 4 metres to allow for guy ropes.

The following conditions are listed for your help and information:-

- 1 The Society reserves the right to refuse any application received without any reason being given.
- 2 Exhibitors must not sublet any portion of the space allotted to them without prior consent, in writing, from the Trade Stand Organiser.
- 3 No auctioneering, lotteries or microphones will be allowed.
- 4 Electricity is not available on the Showground.
- 5 Access to the Showground on the Saturday evening before Show Day can be arranged. The Society will not accept any responsibility for units left on the Showground overnight.
- 6 Exhibitors are requested to take into consideration all ground space needed for public access around their stand when giving measurements. Please allow for guy ropes, caravan draw-bars, etc.
- 7 Any Exhibitor wishing to sell refreshments must first of all contact the Trade Stand Organiser to see if this is permissible.
- 8 No applications accepted after 10th July 2009.

The Society is now accepting applications for trade stands at the 2009 Show to be held on the showground at Pool-in-Wharfedale, near Otley, Leeds on Sunday 19th July.

The society will require a 100% deposit on application . See item 10 below for the show's cancellation policy.

The following conditions are listed for your help and information:-

- 1 The Society reserves the right to refuse any application received without any reason being given.
- 2 Attractions must not sublet any portion of the space allotted to them without prior consent, in writing, from the Secretary.
- 3 No auctioneering, lotteries or microphones will be allowed.
- 4 Electricity is not available on the Showground.
- 5 Access to the Showground on the Saturday evening before Show Day can be arranged. The Society will not accept any responsibility for anything left on the Showground overnight.
- 6 You are required to take into consideration all ground space needed for public access around you when giving measurements. Please allow for guy ropes, caravan draw-bars, etc.
- 7 Any persons wishing to profit must first of all contact the secretary to see if this is permissible.
- 8 You are required to provide us with a copy of your public liability insurance and risk assessment.
- 9 No applications accepted after 20th June 2009.
- 10 If the show has to be cancelled for any reason outside our control, i.e. outbreak of foot & mouth disease, bluetongue, flooding of show site etc., our refund policy is;
 - A) If cancelled more than 30 days before the show date, refund of 100% of fees less 5% administration charge.
 - B) If cancelled less than 30 days before the show date, refund of 100% of fees less 10% administration charge.
 - C) If cancelled within 48 hours of show date, no refund.
